About the Juror: France Scully Osterman is one of the leading artists working with the wet-plate collodion process today. She is a guest scholar at the George Eastman House and gives lectures, demonstrations, and workshops throughout the United States, Japan, and Europe. She presently manages Scully and Osterman from their studio in Rochester, New York.

Eligibility: All prints made using an alternative process are eligible and the exhibition is open to all subject matter. Examples of acceptable processes are albumen, collotype, cyanotype, daguerreotype, gum bichromate, photogravure, platinum and palladium, Polaroid transfers, van dyke, and wet-plate collodion. No digital, c-prints, or gelatin silver prints will be accepted unless combined with an alternative process. For further questions regarding eligible processes e-mail info@tiltgallery.com. Work should have been completed in the last three years.

How to Enter: Jurying will be from digital images only. Minimum three images per artist (each artist must submit three images) any additional images can be sent for \$5.00 per each image. Submit Jpeg files on CD only. Files should be 150dpi and no larger than 1000 pixels in the longest dimension. Title file with the number that corresponds to the submission form, title of the piece, and your first and last name. (example: 1_Title_BobSmith). **Images on CD must Accurately represent the work being submitted. Tilt Gallery retains the right to reject any work that is not accurately represented by the CD. CDs will not be returned.**

Deadline for Submissions: All entries must be received by 5pm on Friday, March 23rd, 2007. Notification of acceptance will be sent the week of April 23rd. Framed work needs to be arrive at the gallery between May 23rd and May 25th.

Entry Fee: \$25 for three images. Send any additional images for \$5.00 per image. Check or money order accepted; make check payable to Tilt Gallery.

Award: First place will receive \$150, second place will receive \$100, and third place will receive \$50.
